## DESCRIPTION

It consists of two sub-modules: the first explores the fundamentals of resettlement and humanitarian admission, including global commitments and EU Member State practices, while the second outlines the process phase by phase, detailing key activities, stakeholder roles, and responsibilities. Through practical examples and interactive learning, the module equips learners with a comprehensive understanding of the resettlement framework and its implementation.
