## DESCRIPTION

This module provides an overview of the Eurodac database, including its scope and purposes on the basis of Regulation (EU) 2024/1358 (the 'Eurodac Regulation'). It also introduces the fundamental concepts of biometric data, outlines the core functions of Eurodac, and focuses on the categories registered and the data processing. This module also provides knowledge of the obligations and rights of people who are subject to Eurodac.
